

How to Place a Texas Court eFiling

Rapid Legal offers eFiling in all 254 Texas court counties. On the provided <u>Rapid Legal login page</u>, type in your email, password and click on the "Login" button. *Please note: We recommend using any modern browser for the best experience*.

Once in the Rapid Legal portal, complete the following:

1. Click on "Place an Order".



2. Select "eFiling" under "What would you like to do?", then select "Texas" under "Select State".
